2. The following are the dates and reminders to remember as regards the different assessment processes:

A. Demonstration Teaching:

- a. Date: May 3, 2021-June 18, 2021
- b. Applicants who signified to undergo demonstration teaching are reminded to submit their recorded demonstration teaching and scanned lesson plan, the link is found in the Division Memorandum.
- c. Also, they are reminded to read and understand the rubrics for rating the demonstration teaching found in the DepEd Orders.

B. Interview: Phone Interview

- a. Date: Anytime from May 3, 2021 to June 18, 2021
- b. Applicants who signified to undergo Interview shall keep their mobile phones open.
- c. The TWG will contact (call or text) the applicant through his/her mobile number at least one (1) day before the interview for instructions.
- d. It is the full responsibility of the applicant to see to it that he/she has a reliable connectivity during the interview.
- e. There are 3 members of the Panel of Interviewers so, the applicant should expect that he/she will be interviewed 3 times.

C. Validation of Specialized Skills:



- a. Date: June 21, 2021-June 25, 2021 – face-to-face or virtual, depending on the skill to be validated
- b. The TWG will contact the applicant (call or text) concerned through his/her contact number at least 1 day before the validation for instructions.
- c. There is only one skills validator.

D. Document Evaluation:

- a. Date: June 21-July 30, 2021

3. Changes in the contact number of the applicant should be updated thru the link which will be posted in the FB Group **SDO-CAPIZ Teacher Applicants S.Y. 2021-22. The applicant assumes full responsibility in the event that he/she cannot be contacted by the TWG due to contact number that is either not updated or erroneous.**

4. It is understood that the schedules and timelines on the conduct of activities stipulated in the previous memoranda which are inconsistent with those which are found herein are hereby rescinded.
5. For the safety of everyone, face-to-face interactions have been significantly reduced. It is reiterated that everyone should observe minimum health and safety protocols and standards at all times during the assessment process.
