It has come to the attention of this Office that a number of higher education institutions OUTSIDE of Western Visayas are operating different graduate programs without the necessary government authority from the Commission and are targeting DepEd teachers and faculty members from different colleges who wanted to earn their graduate degrees for promotion. These HEIs are believed to be operating in Iloilo City, Antique, Iloilo Province and Roxas City, Capiz.

With reference to the aforementioned please be informed that government authority to operate programs from the Commission are campus-specific hence, cannot be offered anywhere. Hence, **NO GRADUATE PROGRAM/S OFFERED BY ANY HIGHER EDUCATION INSTITUTION in the Region or outside of the Western Visayas were given the authority to operate beyond their authority.**

This Office is earnestly requesting your Office to help in the advocacy to put a stop on the proliferation of these HEIs by enjoining your faculty not to enroll in these type of programs nor to consider the units earned for promotion.
