## **RULES AND MECHANICS**

### **I. VIRTUAL DEBATE EXHIBITION**

1. The Virtual Debate Exhibition is open only to the participating schools that registered as student participants of the camp. It will be conducted via Zoom.
2. There shall only be four (4) teams that will compete for two (2) matches, Match A and Match B. There will be two (2) winners that will be declared, one for Match A and another for Match B. Each participating school may signify the intention to participate in the debate on or before **04 February 2022**. Only the registered student-participants of the camp will be eligible to participate in the debate. Other schools who wish to join the contest may be accommodated on a standby basis in the event the competing team/school withdrew.
3. Penalty: The team/school which signifies its intention to join but decided to withdraw from the contest shall pay a damage fee of Php3,000.00/school to the BYLI organizing committee. The team/school which decided to withdraw from the debate contest may do so not later than **11 February 2022**. They will be replaced by other schools that are on the standby list.
4. The school/debating team that has been accepted to participate in the debate competition shall be notified by the BYLI organizing committee on or before **07 February 2022**.
5. Each debating team shall be composed of six (6) members. Any *bona fide* student of the school can be members of the team. The list of the team members shall be submitted at least (3) days before the start of the camp with their designations, either as a speaker (1st, 2nd, or 3rd) or as a researcher, duly signed by the Dean/Principal/President of the school/Adviser/Coach.
6. The debate shall observe the Oxford-Oregon Debate Format. There shall only be THREE SPEAKERS for each side, the three (3) other members shall be ALTERNATES/RESEARCHERS.
