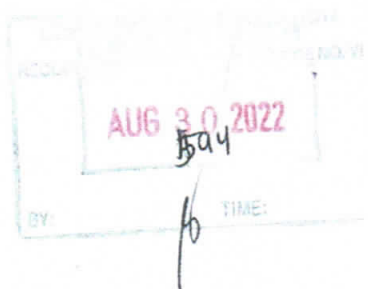

In order to provide assistance to "students-in-crisis", to help defray expenses and/or cost of sending students or children to schools such as school fees, school supplies, school projects, allowances and other related expenses, the Department of Social Welfare and Development Field Office VI (DSWD FO VI) has started the distribution of Educational Assistance for Students in Elementary, High School, Senior High School, and Vocational or College Students through the Individuals in Crisis Situation (AICS) Program last August 20, 2022.
