WATER YOU DOING? EXTEMPORANEOUS SPEAKING CONTEST MECHANICS

Background

In line with the celebration of the World Water Day, the DENR- Environmental Management Bureau Region 6, through its environmental education and information unit, is launching an extemporaneous speaking contest centered on the topic of water management and water awareness.

The Water You Doing? extemporaneous speaking contest provides a platform for Western Visayas residents to showcase their wide array of information and to engage the youth to know more about the bodies of water and its management in their vicinities. This is one way of advocating for the bodies of water found in our region.

Guidelines

- 1. The contest is open to all Senior High School students studying in public and private schools in Region 6.
- 2. The said contest is free of charge. No registration fee shall be collected from the contestants.
- 3. All participants must:
 - a. submit proof of enrollment in the said school in the academic year 2022-2023 (latest registration form or validated school ID)
 - b. register in the Google form for validation.
 - c. be in school uniform during the contest proper.
- 4. The order of competition will be made before the contest proper.
- 5. The picking of questions will be made before each speaker.
- 6. The contestant shall be given 3 minutes to prepare after giving him/her the question, and 5 minutes to deliver his/her speech.
- 7. A timer will be made visible on the screen.
- 8. There will be a 1-point deduction for every 10-second overtime from each judge's scorecard before determining the rank of the contestants.
- 9. The style of delivery shall be conversational, oratorical, or a combination of both.
- 10. Participants must register in the Google forms by 12 midnight of March 10, 2023 to 11:59 pm of March 17, 2023.

- 11. The contest will be judged by a committee organized by the DENR EMB 6 EEIU whose decision will be final.

Criteria

The entries will be judged based on the following criteria:

- A. Content 40%
- B. Delivery 30%
- C. Pronunciation, enunciation, and diction -20%
- D. Stage presence 10%
