This has reference to the Regional Memorandum no.01, s.2023 re: Updated instruction on school reporting for the Pantawid Pamilya Pilipino Program (4Ps)

In connection to the above mentioned memorandum, it was issued to update the Department's guidance on school reporting for the Pantawid Pamilya Pilipino Program (4Ps). As specified in the Implementing Rules and Regulations (IRR) of the Republic Act (R.A. No. 11310) otherwise known as "An Act Institutionalizing the 4P's"DepEd, as member of the National Advisory Council and Regional Advisory Council, "shall align similar systems for 4Ps and help monitor and evaluate the program operations particularly on the compliance of the qualified household – beneficiaries with the conditions for education.

In accordance with the IRR, to help monitor the operations of 4Ps it shall entail providing the Department of Social Welfare and Development(DSWD) necessary information that schools already collect in existing systems (e.g. keeping a record of learner's attendance) and NOT creating new systems or adding new tasks especially to teachers.

Anent this, we would like to formally inform you that we will be conducting re-orientation /orientation to Teachers/non-Teaching staffs /4Ps Focal in the Province of apiz assigned in the Different Municipalities to provide updates to 4Ps counterpart for the monitoring. The orientation will be set from April 25, 2023 until May 12,2023.
