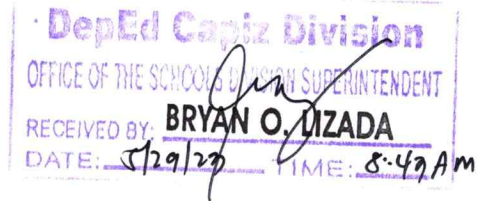

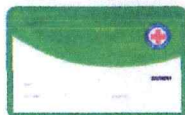

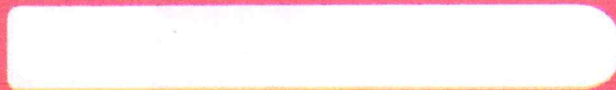

PHILIPPINE RED CROSS MEMBERSHIP PROGRAM

To: Bureau and Service Directors
Regional Directors
Schools Division Superintendents
Public and Private Elementary and Secondary Schools Heads
All Others Concerned

1. The Philippine Red Cross (PRC) encourages the learners, the youth and all individuals, regardless of status, to become members of the PRC and to support its fund drive program. This is pursuant to Republic Act No. 10072 entitled *Philippine Red Cross Act of 2009*.

2. The bonafide member of PRC can gain the following personal accident assistance benefits with the minimum annual membership fee of Sixty Pesos (P 60.00):

| Benefit | Amount |

| Accidental Death, Disablement and Dismemberment | P 12,000.00 |
| Unprovoked Murder and Assault | P 12,000.00 |
| Accidental Medical Reimbursement | P 5,000.00 |
| Accidental Burial Assistance | P 5,000.00 |
| Daily Hospital Allowance | P 150,00/day |

3. Membership and collections are on a voluntary basis subject to the provisions stated in DepEd Order No. 41, s. 2012 entitled *Revised Guidelines on the Opening of Classes*.

4. Likewise, the DepEd employees are encouraged to become members.
