The Bangko Sentral ng Pilipinas (BSP) Visayas Regional Office, in collaboration with BSP Roxas Branch will be conducting the BSP Piso Caravan in various selected areas in Roxas City which covers the: (1) exchanges of coins and unfit currencies with the public; (2) learning sessions covering topics on Digital Payments and Cyber Hygiene Practices, BSP Clean Note Policy and BSP's Coin Recirculation Program and 1000-Piso Polymer Banknote; and (3) account onboarding activities with financial service providers (FSPs).
