#### I. RATIONALE

The Capiz Provincial Environment and Natural Resources Office (CaPENRO) was created to develop and manage environmental plans and programs for a sustainable and resilient Capiz. This includes formulating and implementing activities that strengthen the environmental awareness of Capisnon.

On July 30, 2019, Ordinance No. 001, Series of 2019 (2019-2022) entitled "Declaring the Month of November as the "Provincial Environment Consciousness Month", Institutionalizing its Yearly Celebration and For Other Purposes" was passed by the Sangguniang Panlalawigan.

According to EMB-DENR Region VI, Capiz is the very first province in Western Visayas to have its Environment Consciousness Month (PECM) institutionalized for celebration every November. It is dedicated to raising consciousness on environmental protection, conservation and restoration through a collaborative interagency and multi-sectoral effort.

CaPENRO is the implementing arm of the Provincial Government of Capiz in spearheading the celebration.

For many years, individuals, sectors and institutions have started initiatives to contribute to the restoration, protection, and preservation of our environment. With solid intrinsic motivation, dedication to serve, and strong will, Capisnons responded to the call of the time and took their advocacy seriously. These initiatives, dedication, and hard work must be recognized and should be set as an example.

This 2023, CaPENRO will once again launch the Dungog Lunhaw: Search for outstanding environmental initiatives. #### **OBJECTIVES**

# **INDIVIDUAL CATEGORY (5 WINNERS)**

This award is given to a Capisnon whose initiatives, involvement and dedication significantly contributed to the environmental protection and conservation, ecological sustainability, disaster resiliency, pollution control, and culture-sensitive management of the natural environment of the Province of Capiz.

#### SCOPE OF INITIATIVES

Environmental initiatives shall focus on but not be limited to the following:

 FOREST-BASED INITIATIVE. Focuses on sustainable forest management, stewardship, and community development, the wise use of forest resources and

- 2. COASTAL MANAGEMENT INITIATIVE. Involves promotion and action towards sustainable use, development, protection, conservation, and rehabilitation of seaside terrestrial and coastal marine areas and their resource through the development of innovative approaches, techniques, and programs, community development, public awareness, and education.
- 3. POLLUTION CONTROL AND SOLID WASTE MANAGEMENT INITIATIVE. Focuses on the reduction, elimination, or minimization of solid waste and/or air, water, and land pollution by promoting green or environmentally preferred practices and the application of sustainable design principles.
- 4. CLIMATE CHANGE MITIGATION AND ADAPTATION INITIATIVE. Focuses on the conservation, protection, and restoration of Capiz's environment and ecology through their relentless efforts to reduce greenhouse gas emissions and strengthen resilience and adaptive capacity to climate-induced impacts, including climate-related hazards; integrating climate change measures, strategies, and planning; and improving education, awareness-raising and human and institutional capacity concerning climate change mitigation, adaptation, impact reduction, and early warning.

#### **ELIGIBILITY CRITERIA**

For the initiative to be considered for the Dungog Lunhaw 2023, it must meet the following minimum requirements, it;

- Must be implemented in the Province of Capiz by a Capisnon or an organization composed of Capisnons or majority of its members are Capisnons based in the province.
- May be a partnership with other organizations such as people's organizations, civil society organizations, community-based organizations, or local government units but the proponent and head implementor should be the nominee.
- Must have been in operation for at least a month before the deadline for submission
- Must have verifiable and significant results.

Though the submission of more than one entry is allowed, they must not be interrelated. Initiatives that are nominated for individual categories could no longer be nominated for the organization category. Participants are encouraged to package the programs that are directly connected as one comprehensive entry.

#### **GENERAL GUIDELINES**

- Highlight what makes the program different or better.
- Provide all the required information and make sure that no item is left blank.
- · Responses may be in English or Filipino.
- For parts that require narratives, please be concise and straightforward in your answers. Encode your application form in letter size (8.5 x 11 inches), with margins at 1 inch for all sides (top, bottom, left, and right). Kindly use Arial as the font and font size at 11 points.

# CONSTITUTING THE "DUNGOG LUNHAW 10: SEARCH FOR TEN OUTSTANDING ENVIRONMENTAL INITIATIVES" COMMITTEE AND FOR OTHER PURPOSES

**WHEREAS**, Section 16, Article II of the 1987 Philippine Constitution provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

**WHEREAS**, Republic Act No. 7160, otherwise known as Local Government Code of 1991, mandates the Governor, as the Chief Executive of the Provincial Government to adopt adequate measures to safeguard and conserve land, mineral, marine, forest, and other resources of the province, in coordination with the mayors of component cities and municipalities as provided in Section 465(b)(3)(v);

**WHEREAS**, Republic Act No. 9512, otherwise known as National Environmental Awareness and Education Act of 2008, mandates the promotion of environmental awareness through environmental education and for other purposes;

**WHEREAS**, Ordinance No. 001, Series of 2019 (2019-2022), declares the Month of November as Provincial Environment Consciousness Month, institutionalizing its annual celebration;

WHEREAS, Dungog Lunhaw 10: Search for Ten Outstanding Environmental Initiatives, an annual recognition program aligned with the Provincial Environmental Consciousness Month, celebrates Capisnon's excellent and outstanding leadership in initiating and implementing programs for the conservation, protection, and restoration of Capiz's environment and ecology, enforcement of national laws to combat transboundary environmental issues, and creating solutions to complex environmental challenges through sustainable practices and education;

**WHEREAS**, the Provincial Government of Capiz recognizes the importance of collaboration and partnership among Local Government Units (LGUs), Non-Government Organizations (NGOs), Private Sector, Academe, and Civil Society in providing environmental awareness;

NOW, THEREFORE, I, FREDENIL H. CASTRO, by the virtue of the authority vested in me as Governor of the Province of Capiz, do hereby order the constitution of the DUNGOG LUNHAW 10: SEARCH FOR TEN OUTSTANDING ENVIRONMENTAL INITIATIVES COMMITTEE, naming its composition and functions, to wit:
