PAGBINA-ISAY 2023: AN INVITATIONAL DEBATE COMPETITON (Secondary Category)

RULES AND MECHANICS

- There shall ONLY be four (4) competing teams in the SECONDARY category. ONLY the first four (4) debating teams to register shall be the official competing teams.
- 2. Once the four (4) competing teams are finalized, the representatives of each participating school are required to attend the Coordination Meeting to be scheduled by BYLI at BYLI Office: Unit 1, 2nd Floor, EAS Building 2, Magallanes Street, Roxas City, Capiz. Telephone No. (036) 620-5010.
- Each competing team shall send a minimum of six (6) and a maximum of ten (10) members. Only bona fide student in the senior high school can be members of the team.
- Active participation of the schools are highly required. The participating schools that registered to join but decided to withdraw from the contest shall pay a **penalty fee of P3,500.00**. The participating school which decided to withdraw from the debate contest may do so ON OR BEFORE 20 October 2023. The same penalty in the amount of P3,500.00 shall be imposed to a school that withdrew after the DEBATE WORKSHOP and two (2) weeks before the actual DEBATE COMPETITION.
- Prior to the debate tournament, all members of each debating team are required to attend the One-Day Debate Workshop tentatively scheduled on 27 October 2023. Only those who have attended the Debate Workshop will be allowed to participate in the debate tournament. A registration fee in the amount of P500.00 shall be charged to each participant to cover the cost of the AM/PM snacks and lunch, administrative cost and other expenses.
- The list of the team members shall be submitted at least (3) days before the scheduled match with their designations, either as a speaker (1st, 2nd, or 3rd) or as a researcher or alternates, duly signed by the Student Affairs Director or Coordinator/Dean/Principal/President of the school.
- The tournament shall observe the Oxford-Oregon Debate Format. There shall only be THREE (3) SPEAKERS and THREE (3) RESEARCHERS for each side. The other members shall be ALTERNATES.
- The First, Second, and Third speakers shall discuss the NECESSITY, BENEFITS, and PRACTICABILITY, respectively, of the Proposition of Policy. Any of the three (3) speakers and three (3) researchers shall present the REBUTTAL.

- 9. The medium of the debate shall be 70% Hiligaynon and 30% English.
- The ORDER OF PRESENTATION shall be as follows: 10.

FIRST AFFIRMATIVE Constructive Speech Interpellation by the First Negative FIRST NEGATIVE Constructive Speech Interpellation by the First Affirmative SECOND AFFIRMATIVE Constructive Speech Interpellation by the Second Negative SECOND NEGATIVE Constructive Speech Interpellation by the Second Affirmative THIRD AFFIRMATIVE Constructive Speech Interpellation by the Third Negative THIRD NEGATIVE Constructive Speech Interpellation by the Third Affirmative **BREAK NEGATIVE** Rebuttal AFFIRMATIVE Rebuttal

11. Time Allotment

CONSTRUCTIVE SPEECH 5 minutes (except first affirmative speaker

- 7 minutes

5 minutes INTERPELLATION 7 minutes BREAK **REBUTTAL** 5 minutes

- The speaker during his/her constructive speech shall only be allowed to communicate with the other members of the debate team on stage through WRITTEN NOTES, except during break.
- 13. Members of the debate team shall not be allowed to use laptops, cellphones and other electronic gadgets on stage while the debate is going on.
- The Proposition of Policy and the Definition of Terms shall be agreed upon by the competing teams. (The AFFIRMATIVE SIDE shall have the privilege to define the terms but the terms must be presented to the negative side for consensus). The definition of terms of the affirmative side must be submitted to negative side and to the organizing committee (byli.philippines@gmail.com) three (3) days before the start of the competition.
- 15. Time Signals.

Time begins when the SPEAKER BEGINS TO SPEAK. The BLUE FLAG and A RING OF THE BELL signals that only 1 minute is left. The RED FLAG and TWO RINGS OF THE BELL signal the end of the time allotment.
