ALTERNATION OF THE METE

Dear Dr. Aposin:

This pertains to the conduct of the *Pedersayon ng mga SK* Elections, pursuant to Section 21(3b) of the SK Reform Act of 2015, as amended by RA No. 11768, the *Pederasyon ng mga SK* at all levels shall elect from among themselves a president, a vice president, a treasurer, a secretary, and such other officers as they may deem necessary.

Section 21 of Republic Act (RA) No. 10742, as amended, states that the *Pambayan* and *Panlungsod* na *Pederasyon* ng mga Sangguniang Kabataan (SK) will be composed of the SK Chairpersons of barangays in the Municipality/City, while the *Panlalawigang Pederasyon* ng mga SK, will be composed of the Presidents of the *Pambayan* and *Panlungsod* na *Pederasyon* ng mga SK.

Pursuant to DILG MC 2023-168, the orientation and elections of the Officers of the Pederasyon ng mga SK shall be conducted in one (1) day only. Further, the orientation and elections of the Pambayan at Panlungsod na Pederasyon ng mga SK will be held not later than November 14, 2023, while the orientation and elections of the Panlalawigang Pederasyon ng mga SK will be held not later than November 29, 2023.

With the foregoing, this office respectfully requests the Heads/Presidents of Secondary Schools Education that concerned students who were elected as SK Chairperson in the recently concluded Barangay and Sangguniang Kabataan Elections (BSKE) be excused from classes and other school activities during the *Pederasyon ng mga SK* Elections.

The support of your office will be an invaluable contribution to upholding the mandates and championing the purpose of the Sangguniang Kabataan.
