Greetings from the teachers' union!

Section 1 of DepEd Order No. 51, s. 2003 dated June 19, 2003, entitled "Teacher Orientation to Public Sector Unionism", states that "Consistent with the constitutional right to self-organization of civil servants and the guidelines issued on this matter under Executive Order No. 180, all public school teachers and other non-teaching personnel must be provided with relevant and adequate information on the legal bases of public sector unionism. This includes the information on their benefits or advantages derived from their active participation in the union to protect their interests which lead to the delivery of a more effective, efficient and dependable services to the general welfare." Further, Section 1, Art. IV (Negotiating Unit Members' Education Program) of the DepEd and ACT-Region VI Union Collective Negotiation Agreement (CNA) provides that "The DepEd-Region 6 shall provide full support to the Union in the conduct of the training and seminars for all Region 6 teachers within the negotiating unit for the purpose of enlightening them of their rights, privileges, obligations and responsibilities under the law and this agreement....."

Anent to this, we would like to ask permission from your good office to allow Mr. Maximo B. Montero, Teacher II of Pavia NHS and President of ACT Region VI-Union, and other ACT Region VI-Union Representatives, to conduct teacher orientation on public sector unionism in the different schools in the Schools Division of Aklan, Antique, Capiz, Guimaras, Iloilo, Iloilo City and the Negros Occidental Island Schools Divisions.
