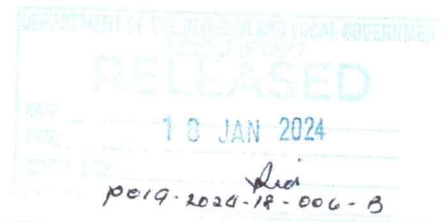
Attached is the letter from the Commission on Vocation of the Archdiocese of Capiz pertaining to the conduct of its Annual Vocation Campaign.
