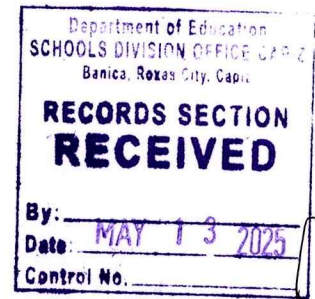

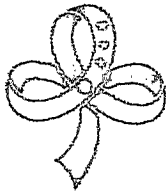


This is to inform everyone that the Council Board Orientation for Aklan, Antique, Capiz and Iloilo Girl Scout Councils has been scheduled as follows:
