#### Application for financial assistance in the GSP-MMAF is approved if the following conditions are met:

- 1. The application for financial assistance -GSP FARF was submitted to GSP NHQ-Manila before the 60<sup>th</sup> day after the accident/incident.
- 2. The required documents were submitted to GSP NHQ-Manila not beyond 90 days aPfter the accident.
- 3. The receipts were found to be valid, correct and not spurious and tampered.
- 4. For medical reimbursement, only members who met an accident are entitled. Thus, No reimbursement will be given to confinement due to natural illness. This is NON APPEALABLE.

### D. SUBMISSION OF THE FINANCIAL ASSISTANCE REQUEST FORM (GSP-FARF) and SUPPORTING DOCUMENTS

The **GSP-FARF**-a written request for financial assistance must be submitted to GSP-NHQ Manila through the Council Office within **sixty (60) days** from the date of the accident/death.


All required supporting documents to the application for financial assistance must be complete. These will be submitted to the Council which in turn will submit it to GSP-NHQ Manila within sixty (60) days but not exceeding ninety (90) days from the date of accident/death. The GSP FARF and supporting documents should be accomplished in triplicate.

It is therefore requested that this information be disseminated to those concerned in the field.

RE: FUND RAISING CAMPAIGN - "5 for 85 (for CAMP ESCODA)"

DATE : June 18, 2025

The Girl Scouts of the Philippines (GSP) is now in its 85th year of providing girls and young women with opportunities for character development, responsible citizenship, leadership, and service to the community.

As an offering for the yearlong anniversary celebration, a National Fund Drive named "5 for 85 (for Camp Escoda)" was launched on May 26, 2025, during the GSP 85th Anniversary Celebration at the GSP National Headquarters in Manila. It will run from July 2025 to June 2026 and is intended for the development of the 27-hectare Camp Escoda (Josefa Llanes Escoda National Program and Training Center, or JLE NPTC), located in Palayan City, Nueva Ecija.

This fundraising campaign for Camp Escoda is not just a mere campaign for the Camp but also an opportunity for all the Councils to benefit from this project. Girl Scouts and adult members registered for the fiscal year 2025-2026 will feel they are contributing to the development of Camp Escoda and will have a sense of its ownership.

Herewith are the objectives and guidelines:

#### FUNDRAISING CAMPAIGN FOR CAMP ESCODA - "5 for 85 (for Camp Escoda)"

"How can I halp?" This is often the question many of our young Girl Scouts ask when considering how they can contribute. Some might think, "How can I halp when I only have this much?" That is why the Fund Development Committee came up with an idea to show how a young Girl Scout can contribute in building our Camp Escoda in Palayan City, Nueva Ecija.

#### A. OBJECTIVES

- 1. To continuously generate funds for the development of Camp Escoda.
- 2. To help girls feel ownership when they have contributed in the building of Camp Escoda.

#### B. **GUIDELINES**

- 1) This Fund Campaign will be from July 2025 to June 2026 only.
- 2) **Beginning July 2025**, all registering Girl Scouts and adult members will **make** an offering/donation of **FIVE PESOS (P 5.00)** for the development of Camp Escoda.

3) For every Five Pesos collected, the council will receive a Two-Peso (P 2.00) share that can be used for council training, programs, or operations. The remaining Three Pesos (P3.00) will be sent to the National Headquarters to support the Camp Escoda project.

Note: Please note that the Regional Office will also receive Two Pesos (P2.00) for each Girl Scout and adult member registered with their office.

4) Each Five-Peso (P5.00) donation/offering will be included/receipted in the acknowledgement receipt (AR). Similar to the collection for the Council Support Fund (CSF), a council receipt must be issued for the Two Pesos (P2.00) share from the total P5.00 collected, indicating the number of girls registered. The total remittance to the National Headquarters for every registration will therefore be Forty-Three Pesos (P43.00).
