PAGLALISAY: 1st INTER SECONDARY SCHOOLS OF TAPAZ, CAPIZ DEBATE GUIDELINES OXFORD-OREGON FORMAT

I. Overview

These guidelines outline the structure, rules, and procedures for the upcoming secondary school debate competition using the Oxford-Oregon format. This format promotes **critical thinking**, **research**, and **effective communication**. Each team will consist of three main speakers and three researchers who will collaboratively develop arguments grounded on the **BNP** framework: **Beneficiality**, **Necessity**, and **Practicability**.

II. Team Composition

Each team will have a total of six members:

1. Three Speakers

- Speaker I (First Speaker)
- Speaker 2 (Second Speaker)
- Speaker 3 (Third Speaker)

2. Three (3) Researchers

 Researchers support speakers by preparing data, evidence, and rebuttals but do not speak during the debate.

III. Language Requirements

I. Languages Permitted

- English
- Filipino
- Hiligaynon

2. Constructive Speech

 Must be delivered in English to ensure clarity and uniformity when presenting key arguments, including the beneficiality, necessity, and practicability of the team's position.

3. Interpellation

 May be conducted in English, Filipino, or Hiligaynon, allowing flexibility and accessibility in argument engagement.

IV. Debate Format (Modified Oxford-Oregon)

1. Roles of Speakers

- Speaker I (First Speaker Beneficial)
 - o Delivers the constructive speech focusing on the beneficiality of the motion.
 - Explains why the proposal is good, its advantages, and the positive impact it would bring.
 - Sets the tone and framework for the team's case.

Speaker 2 (Second Speaker – Necessary)

- o Presents arguments emphasizing the necessity of the proposal.
- Explains why the motion must be implemented, highlighting urgency or critical need.
- Strengthens the team's position and begins responding to opposition arguments.

Speaker 3 (Third Speaker – Practical)

- Focuses on the practicability of the proposal.
- Shows how the motion is doable, realistic, and can be implemented effectively.
- o Addresses any feasibility concerns raised by the opposing team.

Debate Captain (Rebuttal and Summary Speaker)

- Delivers a strong rebuttal, systematically refuting the opposing team's arguments across the BNP framework.
- Summarizes the team's case, reinforcing the beneficial, necessary, and practical strengths.
- Provides a compelling closing statement that ties the team's arguments together.

2. Researchers

- · Provide real-time support during preparation and delivery.
- Assist in fact-checking, data provision, and strengthening BNP-based claims and counterclaims.

V. Debate Procedure

1. Opening Statements (Constructive Speeches)

- Speaker I from each team introduces their side, focusing solely on the beneficial aspect.
- o Speaker 2 follows, concentrating on necessity.
- o Speaker 3 delivers the practicability component of the argument.

2. Interpellation

- After each constructive speech, the opposing team may ask questions to challenge the speaker's arguments.
- Questions should specifically aim to expose weaknesses in beneficiality, necessity, or practicability.

3. Rebuttal and Summary

- The Debate Captain addresses and refutes key opposition points across BNP dimensions.
- Closes the case by summarizing the team's strongest arguments and restating why their position is superior.

VI. Time Allotment

- Speaker 1,2,3 (Constructive Speech): 4 minutes
- Debate Captain (Rebuttal and Summary): 5 minutes
- Interpellation: 3 minutes total (shared by both teams)

A warning bell will be rung I minute before the time limit. A final bell signals the end of a speaker's time.

VII. Judging Criteria

1. Argumentation and Constructive Development (30%)

- Clarity and strength of the team's primary arguments
- Effective use of the BNP framework (Beneficiality, Necessity, Practicability)
- · Relevance and depth of evidence
- Organization and logical structure of the constructive speech

2. Interpellation and Refutation (30%)

- · Skill in posing pointed, relevant, and strategic questions
- Composure and clarity in responding to cross-examination
- · Demonstrates depth of analysis, critical thinking, and active engagement
- Ability to identify weaknesses and defend key positions during the interpellation

3. Oral Communication and Delivery (20%)

- · Clarity, confidence, and persuasiveness in speech
- Effective use of voice modulation, body language, and stage presence
- Maintains audience and adjudicator engagement throughout the debate

4. Logical Reasoning and Coherence (20%)

- · Logical consistency and internal coherence of arguments
- Clear progression of ideas with strong transitions
- Effective coordination between team members' roles
- · Accuracy and depth of rebuttals demonstrating sound reasoning

Topics will be released in advance. Teams are expected to **analyze the issues using the BNP framework**, ensuring their positions are grounded in logic, relevance, and real-world feasibility.

Secondary level

- I. "Let it be resolved that Congress should pass a law that would define political dynasty and prohibit the same
- 2. "Let it be resolved that the COMELEC should not allow persons with pending cases to run for public office."
- 3. "Let it be resolved that the death penalty should be reinstated in the Philippines."
- 4. "Let it be resolved that divorce should be legalized in the Philippines."
- 5. Let it be resolved that same-sex unions be legalized in the Philippines.
- 6. Let it be resolved that the Senior High School program be abolished in the Philippines.
- 7. Let it be resolved that the use of marijuana for medicinal purposes be legalized
- 8. Let it be resolved that rice importation in the Philippines be strictly limited.
- 9. Let it be resolved that candidates for Congress, Vice President, and President should be required to have higher educational, professional, and relevant leadership experience
