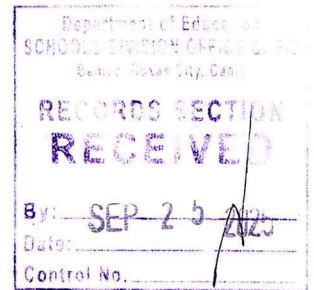

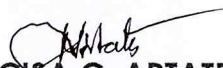

7. Must have earned at least three (3) badges in the 8-point challenge

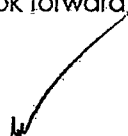
