1. The Capiz Schools Sports Council will hold the **2018 Capiz Provincial Dancesports Competition** on January 24, 2018, 1:00 o clock in the afternoon at Filamer Christian University Gym.
2. The competition aims to select participants who will represent the Province of Capiz to the Western Visayas Regional Athletic Association (WVRAA) Meet Dancesports Competition.
3. Participants to this activity are Coaches/Trainers and **top three winners** (First, Second and Third placers) in all age group of Capiz Division and Roxas City Division. Contestants will compete on the following categories/dances:

JUVENILE (ELEMENTARY)	Syllabus Slow Waltz, Tango, & Quick Step	Syllabus Cha cha cha, Samba and Jive
JUNIOR (SECONDARY)	Syllabus Slow Waltz, Tango, and Quick Step	Syllabus Cha cha cha, Samba and Jive

4. The cut off age of athletes for the elementary level is **January 1, 2005** and **January 1, 2000** for the **secondary level**.
5. The Deadline for the submission of credentials of athletes, coaches and chaperons will be on **January 22, 2018, 4:00 pm** at Capiz Division Multipurpose Hall, Banica, Roxas City. These should be submitted to Mr. Towa Arroyo, Chairman of the Provincial Screening and Accreditation Committee (PSAC) and Mr. Joel Degoma, Co-Chairman.
6. Contest proper will start at 1:00 o clock in the afternoon. Participants are requested to be at the contest venue one hour before the start of the contest for the ocular inspection, registration and drawing of contestant's number.

Travel and other allowable expenses relative to participation to this activity are chargeable against school MOOE, while operational expenses are chargeable against the contingency of the 2018 Capiz Delegation WVRAA participation budget both subject to the usual accounting and auditing rules and regulations.
