DIVISION SEMINAR WORKSHOP FOR YES-O ADVISERS

1. The Schools Division of Capiz through the School Governance and Operations Division (SGOD) and in partnership and coordination with the Division YES-O Advisers Association will conduct the *Division Seminar Workshop for YES-O Advisers* on **August 15-16, 2019** at the venue to be announced later.
2. The activity seeks to achieve the following objectives:
 - a. strengthen the implementation of the Youth for Environment in Schools (YES) Program pursuant to DepEd Order No. 52 s. 2011 (Strengthening Environmental Education in Public and Private Schools and DepEd Order No. 93 s-2011 (Mandated Programs, Projects and Activities to the Youth for Environment in School Programs);
 - b. develop awareness about the science of climate change and its effects in the country;
 - c. improve students' deeper consciousness on the state of the environment focusing on significant issues and concerns;
 - d. encourage students' active participation and determined concrete action in the protection, preservation and rehabilitation of the environment; and
 - e. instill environmental values in every student to motivate actual involvement in worthwhile programs, projects and activities for the environment.
3. Participants to this live-out activity are teacher-advisers of YES-O secondary and Integrated schools. The official participants from each school must be submitted to the Division Office c/o SGOD (*Youth Formation*) using the attached template (**Registration Form**) in hard and soft copy using **Excel Format** on or before **August 5-6, 2019**. **Walk-in participants** will not be entertained.
4. Each school delegation should bring the following:

Extension cord	ball pen
Manila paper	pentel pen
Bond Paper	masking tape
5. The travel and other expenses relative to the holding of this activity shall be charged to school MOOE fund, YES-O, PTA and other sources of funds while the food provision for the participants and facilitators/speakers and materials is chargeable against division **HRTD Fund** subject to the usual accounting and auditing rules and regulations.
