**LEADERSHIP TRAINING FOR SUPREME STUDENT GOVERNMENT
(SSG) PRESIDENTS AND ADVISERS**

To: Public Secondary and Integrated School Heads

1. The Schools Division of Capiz, through the Youth Formation Section under the School Governance and Operations Division will conduct a **Leadership Training for Supreme Student Government (SSG) Presidents and Advisers** on **August 8 and 9, 2019** at a venue to be announced later.
2. The activity aims to:
 - a. provide the participants a refresher on the operations within the SSG among other student organizations pursuant to DepEd Order No. 47 s. of 2014 (Constitution and By-Laws of the Supreme Pupil Government and Supreme Student Government in Elementary and Secondary Schools);
 - b. capacitate the participants for effective implementation of different programs, projects and activities of the Supreme Student Government;
 - c. provide them a venue for collaborative and integrative project formulation, and critique of the dynamic, feasible, doable, and concrete plan of activities and social innovations for implementation in the schools;
 - d. establish a pool of bonded community of public school advisers and coordinators that continuously performs the duty to excel and to lead; and
 - e. increase engagement of public school advisers, coordinators and other stakeholders for school governance and community development.
3. Participants to this live-out activity are the **SSG Presidents, Vice Presidents and Advisers**. Pre-Registration and submission of list of participants will be between **July 29-31, 2019** at the Schools Division Office – **SGOD c/o Youth Formation**.
4. A registration fee of **Eight Hundred Pesos (Php 800.00)** shall be charged each participant to cover expenses for certificates, materials for the activity, meals and snacks of the participants and other operational expenses. The **registration fee, travel and other expenses** relative to the holding of this activity shall be charged to **school MOOE** subject to the usual accounting and auditing rules and regulations.
