September 10 – 13, 2019	Regional Manuscript Screening (RMS)

- The competition is open to all DepEd school teachers with permanent status. Minimum qualifications are outlined in the mechanics of the competition found on page 2 of the above cited memorandum.
- Each district shall submit the Top 3 winning stories (manuscripts) per grade level (Kindergarten to Grade 3) along with following the criteria set found in the aforementioned memorandum and the Official Entry Forms of the writers.
- The guidelines and other details of the competition found in the aforementioned memorandum shall be observed and followed.
- The composition of the Division Screening Committee is found in Enclosure No. 1.
- Travelling and other incidental expenses incurred by the personnel during submission of the division entries (manuscripts, graphic design, and final copies) shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
