**CAMPUS INTEGRITY CRUSADERS (CIC) ORIENTATION AND ACCREDITATION OF
SUPREME STUDENT GOVERNMENT FOR SY 2019-2020**

1. The Schools Division Capiz, through the Youth Formation Section under the School Governance and Operations Division and in partnership with the Office of the Ombudsman (Visayas), will conduct a *Campus Integrity Crusaders (CIC) Orientation and Accreditation of Supreme Student Governments (SSG)* on **July 19, 2019, 8:30 AM** at **Capiz Division Multi-Purpose Hall, Banica, Roxas City**.
2. The activity aims to:
 - a. orient Supreme Student Government (SSG) presidents and advisers of their responsibilities as leaders in school;
 - b. accredit school-based organizations as Campus Integrity Crusaders (CIC) partner; and
 - c. encourage students' participation in corruption prevention initiatives by developing their leadership skills and instilling values of integrity and social responsibility.
3. Participants to this live-out activity are **the newly elected presidents and designated advisers** of the **Supreme Student Government (SSG)** of each secondary and integrated school. The name of participants must be submitted to the Division Office- c/o Youth Formation (SGOD) between **July 1-5, 2019. Walk-in participants** will not be entertained.
4. A registration fee of **Three Hundred Fifty Pesos (Php400.00)** shall be charged each participant to cover expenses for materials, token for the speakers and other operations expenses.
5. The registration fee, travel and other expenses relative to the holding of this activity shall be charged to school MOOE fund, while the food provision for the facilitators/speakers and materials is chargeable against division INSET fund subject to the usual accounting and auditing rules and regulations.
