This is to announce to the field the conduct of 2020 SBM WinS school assessment and uploading of WinS Three Star Assessment 2020 to Online Monitoring System (OMS) starting **January 18 to January 22, 2021**. Schools are enjoined to use the **WinS Monitoring System Form for Schools Version 2017-06-04** which can be downloaded from <https://deped-wins.sysdb.site/Login/>, the same site for the uploading of the accomplished self assessment. Schools are encouraged to upload the said accomplished school self-assessment within the given time frame to avoid glitches in the system.
