

NOW THEREFORE, be it resolved, as it is hereby RESOLVED by the HRMPSB of the Schools Division of Capiz, in a meeting assembled, that any tie shall be resolved by referring to the latest performance rating of the applicants; the one with the higher/highest performance rating will get the higher/highest rank between/among them.

RESOLVED FINALLY, that this policy shall be disseminated to the field through a division memorandum.
