- Relative to DepEd Memorandum No. 37, s, 2022, re.: Resumption of Implementation of the Policy on Checking of School Forms as Prescribed in DepEd Order no. 11, s. 2018 (Guidelines on the Preparation and Checking of Forms), there will be an on-site physical checking of school forms by the Division Checking Committee on July 5-8, 12-14, 2022.
- 2. All schools in both Elementary and Secondary will be checked. Secondary schools will join the district schedule.
- 3. The Division office will deputize school heads as representatives during the checking of school forms so that all schools will be checked.
- 4. Without prejudice to the national and local government-imposed protocols and restrictions pertaining to physical reporting to schools and offices, the checking committees shall perform the checking of school forms in the presence of the class adviser.
- Materials and transportation expenses incurred by the DCC will be charged against SDO funds, while other expenses of the school will be charged to School MOOE subject to the usual government accounting and auditing rules and regulations.
