Date	ACTIVITIES
July 8, 2022	9 AM - Virtual orientation of School Screening Committees (Elementary, Kindergarten, SPed, IPEd, Junior and Senior High School) 1 PM - Virtual orientation of Division Selection Committees, Division Selection Committee TWG in the District, and District RQA Encoders
July 11, 2022	Applicants submit three (3) sets of folders containing letter of application and supporting documents to the school head of the school where they intend to apply (1 copy-school; 1 copy-district; 1 copy-division)
July 12, 2022	School Heads concerned, through the PSDS, submit to the office of the SDS, the composition of the School Screening Committee, for issuance of designation order.
July 11-12, 2022	School Screening Committee (SSC) reviews and authenticates the documents submitted by the applicants
July 11-13, 2022	School Screening Committee encodes OFFLINE the basic data and scores of applicants (template will be given)
July 13, 2022	 School Screening Committee, through the school head, transmits the encoded data (hard copy) of applicants to the District RQA Encoders concerned District RQA Encoders encode ONLINE the transmitted data and ratings of each

July 13-14, 2022	applicant received from the district plus other pertinent data asked for in the google sheet.
July 14, 2022	School Screening Committee submits with 2 copies of transmittal letter noted by the PSDS the list of applicants together with their folders (copy for division office) to the Division Office c/o the Division Selection Committee Secretariat. The Secretariat receives and keeps custody of one (1) copy of the transmittal letter with list of applicants and forwards the folders and one (1) copy of the list of applicants to the EPS/Specialist concerned. Each bundle of folders should be labeled with district name, school, and level (Kindergarten, SPEd, Elementary, JHS-specialization, SHS-Subject Group)
July 13, 2022	School Screening Committee submits to the PSDS the applicants' folders (copy for the district).

July 14-20,	Division Selection Committee TWG in the District
2022	rates the applicants on:
	 Specialized Training and Skills certificate and validation (validation for K to 10 applicants only) Interview, and Demonstration Teaching (for applicants who will Demo using Mother Tongue (to get +5), they should be informed that they will be appointed in K - 3 only, but their points should not exceed 15 points There should be a separate list of Elementary level applicants who did the

	Demo using Mother Tongue where they will get +5.
July 14-20, 2022	Education Program Supervisors concerned sharproceed to the district and rate the applicants of the district assigned to them based on the schedule provided by the PSDS but not later than July 20, 2022: a. Teaching Experience (all applicants from Fto 12); and b. Portfolio/Outstanding Accomplishment (for SHS applicants) They shall record the scores in hard copy template will be provided

July 18-22, 2022	Tentative date of EPT (to be scheduled by batch)
July 21-22, 2022	District encoder encodes online the applicants' rating (using the form provided for) on Validate Specialized Training and Skills, Interview, and Demonstration Teaching, Portfolio, etc.
	District retains the folders- District Copy of the applicants in the District Office for future reference
July 25-26, 2022	District TWG validates in the presence of applicants their tentative points earned in each criterion (except EPT if not yet available) and other basic data. Attendance of applicants to this activity should be properly documented the District TWG
July 27-29, 2022	Division Selection Committee and the district representatives do the final encoding , reviewing and consolidating of the individual ratings of applicants
