As a matter of policy, this Office issues this Memorandum to provide guidance relative to the invitations to events being received by officials of the Department of Education (DepEd). The DepEd officials shall abide by the following protocols:

- DepEd Officials shall not attend inconsequential events. They shall devote their time and
  effort to the faithful performance of our duties and fulfillment of our deliverables.
  Likewise, they shall endeavor to discourage wrong perceptions of their roles as dispensers
  or peddlers of undue patronage.
- DepEd Officials shall only represent the Secretary or the Department in any event upon the issuance of an authorization signed by the Head Executive Assistant and/or the Secretary.
