IMPLEMENTATION OF SIX-WEEK BEGINNING READING AND NUMERACY INTERVENTION

To: OIC, Office of the Assistant Schools Division Superintendent Chief Education Supervisors Public Schools District Supervisors Heads of Public Elementary, Secondary and Integrated Schools

- This office, through the Curriculum Implementation Division (CID) announces the implementation of the six-week Beginning Reading and Numeracy Intervention as part of our Basic Education Learning Recovery and Continuity Plan (BE-LRCP) in all schools starting September 12- October 21, 2022.
- 2. This intervention is intended to address the presence of non-readers and non-numerates among the Key Stage 1 learners.
- 3. Specifically, this intervention aims to:
 - a. place greater emphasis on the foundational literacy and numeracy skills of the learners;
 - b. help teachers deliver better instruction on foundational literacy and numeracy acquisition for all K-3 learners; and
 - c. improve the literacy and numeracy level of learners.
- 4. The teachers in Key Stage 1 with learners who are assessed to be non-readers and non-numerates are advised to teach beginning reading and numeracy. Differentiated instruction shall be implemented to the other learners.
- 5. Schools with non-readers and non-numerates in other grade levels must implement a remediation initiative.
- 6. Activities for the implementation of the Beginning Reading and Numeracy Intervention.
 - A. Administration of reading assessment
 - B. Result analysis
 - C. Identification of non-readers and non-numerates

- 8. Expenses relative to the conduct of this activity shall be charged to School MOOE while expenses during the activities at the Division level shall be charged to Division MOOE subject to the usual accounting and auditing rules and regulations.
- 9. The conduct of this activity must comply with the minimum health and safety protocols set by the Inter-Agency Task Force on the Management of Emerging Infectious Diseases (IATF) and the Department of Health (DOH).
