- Flora and Fauna
- Local Heroes
- Dances
- Musical Pieces
- Food and Products
- Local talents
- Musical Instruments
- Beliefs and Ritual
- Literary Anthologies

4. Contextualized LR to be submitted can be:

- a. Daily Lesson Log (DLL) with contextualized strategies and assessment and with SRM such as:
 - Story book, e-book
 - Chart
 - Flip picture
