1. In order to ensure that every publication used for document evaluation meets the acceptable standards as to originality/uniqueness of content, all articles submitted for notation by the Human Resource Merit Promotion and Selection Board (HRMPSB) should be accompanied by a printed Content Check Report using the free online content checker **Dupli Checker**. The report should contain a "Unique" level of not lower than 70%.
2. In addition, the soft copy of the article/s for publication should be uploaded to the google form with URL **<https://bit.ly/3sGEX99>** (DepEd Email account log in required) prior to submission of the printed version/s at the division office.
3. This requirement shall take effect for all publications submitted to the office with received date March 1, 2022 and henceforth.
4. Immediate and wide dissemination of and compliance with this memorandum is highly enjoined.
