**CONDUCT OF MID OF SCHOOL YEAR (MOSY) COMPREHENSIVE RAPID LITERACY ASSESSMENT (CRLA) AND ENHANCED REGIONAL NUMERACY TEST (E-RUNT)**

1. In relation to the operationalization of the Basic Education Learning Recovery and Continuity Plan (**BE-LRCP**) to address the gap in reading and numeracy, this office through the Curriculum Implementation Division (CID) shall conduct the Mid of School Year (MOSY) Comprehensive Rapid Literacy Assessment (**CRLA**) and Enhanced Regional Unified Numeracy Test (**E-RUNT**) on February 15-21, 2023.
2. This activity aims to:
  - a. monitor the results of the conduct of the reading and numeracy intervention in schools;
  - b. gather CRLA AND E-RUNT reports, and
  - c. provide technical assistance.
3. Schools are advised to administer the CRLA for Grades 1-3, and the E-RUNT for Grades 2-11 on February 15-21, 2023 and submit the result on February 24, 2023 c/o Dr. Merlie J. Rubio for CRLA and Mrs. Elenia P. Baranda for E-RUNT.
4. It is expected that in the conduct of this activity, all involved must adhere to minimum health and safety protocols set by the Inter-Agency Task Force on the Management of Emerging Infectious Diseases (IATF) and the Department of Health (DOH).
