- Relative to the implementation of the Basic Education Learning Recovery and Continuity Plan (BE-LRCP) and the Reading and Numeracy Roadmap of SDO Capiz to address the gaps and learning losses, the Curriculum Implementation Division (CID) shall conduct an on-the-spot reading and numeracy assessment beginning April 2023.
- 2. This activity aims to:
 - a. monitor the results of the conduct of the intervention in schools in key stage 1 for reading and numeracy of priority districts;
 - b. gather feedback;
 - c. provide technical assistance; and
 - d. recognize the effort of teachers and school heads in filling the gaps caused by the pandemic.
- 3. The assessors shall be composed of the Education Program Supervisors and Public Schools District Supervisors, headed by the Chief Education Supervisor of CID, Dr. Segundina F. Dollete.

- 4. Education Program Supervisors in charge of MTB/MLE, Filipino, English, and Mathematics will develop the assessment tool to be used during the onthe-spot reading and numeracy assessment.
- 5. Teachers with one hundred percent (100%) readers in MTB, FILIPINO, and English and one hundred percent (100%) numerates will immediately receive a certificate of merit.
- Expenses relative to the conduct of this activity shall be charged against the Division MOOE subject to the usual accounting and auditing rules and regulations.
- 7. It is expected that in the conduct of this activity, all involved must adhere to minimum health and safety protocols set by the Inter-Agency Task Force on the Management of Emerging Infectious Diseases (IATF) and the Department of Health (DOH).
- 8. Immediate dissemination of this Memorandum is desired.
