Consistent with Section 5.2 of DepEd Order No. 55, s. 2016 entitled "Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program," the Bureau of Education Assessment (BEA) with the assistance of regional division and school personnel shall administer the Philippine Educational Placement Test on the third (Luzon cluster) and fourth (Visayas and Mindanao cluster) Sundays of November at designated testing centers.
