1. Relative to DepEd Memorandum No. 095, s. 2018 dated 29 May 2018 titled the Implementation of the Gulayan sa Paaralan Program (GPP) in Public Elementary and Secondary Schools Nationwide and DepEd Memorandum No. 223, s. 2016 dated 14 December 2016 titled Strengthening the Implementation of the Gulayan sa Paaralan Program in Public Elementary and Secondary Schools Nationwide, vegetable gardens shall be established and maintained in public elementary and secondary schools to serve as ready food baskets or sources for the school and the community. To ensure its sustainability, schools shall implement various means to ensure a return on investment in the management of their school gardens.
2. In this regard, schools are requested to adopt means to “generate yields and income from their school gardens which they shall use for Feeding Program and sustain production (Item 3.3 Program Management: Utilization of Garden Yields/Proceeds). Measures to ensure ROI shall be monitored by the Division GPP monitoring team headed by the Education Program Supervisor of EPP, TLE, TVL, Dr. Rolando B. Jamora.
3. Relative to sustaining GPP, this office shall conduct a **Division Search for 2023 Outstanding Gulayan sa Paaralan Program Implementers** which aims to highlight the adoption of the Integrated School Nutrition Model (ISNM).
