1. The Department of Education (DepEd), through the **Bureau of Education Assessment (BEA)**, will administer the **National Achievement Test for Grade 10 (NATG10)** for School Year 2022-2023 on **June 27, 2023**, pursuant to DepEd Order No. 55, s. 2016 titled "**Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program**" and DO 34, s. 2022 titled "**School Calendar and Activities for the SY 2022-2023**".
2. The NATG10 will be administered to sampled Grade 10 learners in all public and private secondary and integrated schools offering the Grade 10 curriculum through a paper-based modality.
3. The NATG10 is one (1) of the exit assessments under the national assessment framework of the K to 12 Basic Education Program. It is designed to determine if Grade 10 learners are meeting the learning standards of the Junior High School (JHS) curriculum.
4. To ensure that the guidelines on the test administration, including the roles and responsibilities of the field-testing personnel and the sampling procedure in selecting Grade 10 learners per school will be discussed, this Office will conduct an orientation on the **Standardized Test Administration** of the above-mentioned testing program to


