- 1. In consonance with DepEd Order No. 28, s. 2018 titled "Policy on Oplan Kalusugan sa Department of Education" and Republic Act No. 7719, also known as the National Blood Services Act of 1994, this office through the School Health Section & Nutrition Unit of the School Governance & Operations Division (SGOD) in partnership with the Philippine Red Cross Capiz Chapter will conduct a bloodletting activity with the theme "Dugong Alay, Sagip Buhay" on August 16, 2023, from 8:00 AM to 5:00 PM at the Schools Division Office Activity Area, Banica, Roxas City.
