In consonance with DepEd Order No. 28, s. 2018 titled **“Policy on Oplan Kalusugan sa Department of Education”** and Republic Act No. 7719, **also known as the National Blood Services Act of 1994**, this office through the School Health Section & Nutrition Unit of the School Governance & Operations Division (SGOD) in partnership with the Philippine Red Cross Capiz Chapter will conduct a bloodletting activity with the theme **“Dugong Alay, Sagip Buhay”** on August 16, 2023, from 8:00 AM to 5:00 PM at the Schools Division Office Activity Area, Banica, Roxas City.
