DepEd Order No. 27, s. of 2019 (Guidelines on the Yearly Collection of Data/Information Requirements and Validation Processes), identified the roles and responsibilities of accountable persons from the school and Schools Division Office in ensuring the accuracy and correctness of data reported in the Learner Information System (LIS), Basic Education Information System (BEIS), and National School Building Inventory (NSBI) which includes the conduct of data validation.

Moreover, in the existing data-gathering forms, accountable persons shall certify that the reported data are correct and validated.

To strengthen the accountability of all personnel, and the accuracy and reliability of all the data submitted to the system and the Central Office, all submissions every reporting period shall be accompanied by a Memorandum signed by the Schools Division Superintendent (division report) and Regional Director (regional data report) certifying the correctness of the data and all of these are validated, addressed to the Undersecretary and Assistant Secretary

(Attention: Director of Planning Service). This will cover all reported data in the information systems, special collections, and data for validation.

This mechanism recognizes the crucial role of data-driven and informed decision-making. It also reiterates that all concerned personnel involved in the data collection, the Schools Division Superintendents, and the Regional Directors are accountable for the data reported.

Concerning the Memorandum dated 02 August 2023 re: Validation of Electrical Supply and Internet Connectivity Data of Schools, all Regional Directors shall submit a memorandum certifying that the said data of their respective regions are validated and correct, on or before 12nn of 10 August 2023 to the Planning Service - Education Management Information System Division (PS-EMISD) through the email address ps.emisd@deped.gov.ph.
