ENSURING THE SAFE RETURN OF LEARNERS FOR SCHOOL YEAR 2023-2024

To: Schools Division Superintendents
All Others Concerned

- 1. To ensure adherence to the MATATAG Education Agenda specifically on taking good care of learners by promoting their well-being and providing a positive learning environment, this Office requests the SDOs to follow the guidelines to ensure the safe return of learners for School Year 2023-2024, such as but not limited to:
 - protect learners from abuse, violence, exploitation, discrimination, bullying, and other forms for abuse by strictly implementing DepEd Order No. 40, s. 2012 titled DepEd Child Protection Policy;
 - ensure that healthy and nutritious food and beverages are available to learners in compliance with DepEd Order No. 13, s. 2017 titled Policy and Guidelines on Healthy Food and Beverages Choices in Schools and in DepEd Offices;
 - enjoin compliance with DepEd Order No. 18, s. 2015 titled DepEd Guidelines and Procedures on the Management of Children-at-Risk (CAR) and Children in Conflict with the Law (CICL);
 - provide necessary medical assistance and intervention to learners showing signs and symptoms of illnesses and/or sickness;
 - ensure that school grounds, classrooms and all their walls, and other school facilities are clean and free from unnecessary artwork, decorations, tarpaulin, and posters at all times. Oversized signages with commercial advertisements, words of sponsorships, and/ or endorsements or announcements of any kind or nature shall be taken down in compliance with DepEd Order No. 21, s. 2023 titled 2023 Brigada Eskwela Implementing Guidelines. Classroom walls shall remain bare and devoid of posters, decorations or other posted materials. Classrooms should not be used to stockpile materials and should be clear of other unused items or items for disposal; and
 - request assistance from local law enforcement entities to ensure peace and order within the vicinity of the school.
