- 1. In reference to Memorandum DM-CT-2023-230 re: Administration of the National Learning Camp Assessment (Post-Test) for Incoming Grades 8 and 9 Learners for SY 2023-2024, this Office, through the School Management, Monitoring, and Evaluation (SMME) Unit of the School Governance and Operations Division (SGOD) and the ICT Services Unit, informs all public junior high schools of the Administration of the National Learning Camp (NLC) Assessment (Post-Test) for Grades 8 and 9 Learners, SY 2023-2024.
- 2. The NLC Assessment Post-Test shall be administered from August 31 September 22, 2023 to all Grades 8 and 9 learners enrolled in all public junior high schools in SY 2023-2024 who have taken the Pre-Test, whether or not they have participated in the National Learning Camp.
- 3. To revisit the testing guidelines and mechanics of the NLC Assessment Post-Test, an online division orientation shall be held on September 6, 2023, 1:00 PM-3:00PM via MS Teams. Participants to this orientation are school heads, school testing coordinators, and the test administrators of the 27 NLC Assessment (Pre-Test) participating junior high schools.
- 4. Schools heads are instructed to implement necessary arrangements to ensure that no inperson classes are disrupted by the attendees' participation in the division orientation, in strict compliance with DepEd Order No. 9, s. 2005 on Instituting Measures to Increase Engaged Time-on Task and Ensuring Compliance Therewith and other existing DepEd rules and regulations.
- 5. Attached is the list of the NLCA participating schools and the originating schools of the test administrators, for your reference.
- 6. Immediate dissemination of and compliance with this Memorandum are desired.
