2023 BRIGADA ESKWELA SERVICE CREDITS FOR TEACHING PERSONNEL AND COMPENSATORY TIME-OFF FOR NON-TEACHING PERSONNEL

- 1. Pursuant to DepEd Order No. 021, s. 2023 titled "2023 Brigada Eskwela Implementing Guidelines", this Office, through the Social Mobilization and Networking Unit (SocMob) under the School Governance and Operations Division (SGOD) informs the field of the submission of documentary requirements for teaching and non-teaching personnel entitled to earn vacation service credits arising from their active involvement as members of the school Brigada Eskwela working committees and/or voluntary services in the Brigada Eskwela activities on or before September 27, 2023.
- 2. Teachers shall earn one-day service credit for accumulated eight (8) hours of services as committee members and/or volunteers in the school preparation and partnership engagement activities, but not to exceed a total of six (6) days service credits. The computation of the service credits to teachers shall be in consonance with DO 53, s. 2003 titled "Updated Guidelines on Grant of Vacation Service Credits to Teachers", particularly, Item No. 1-d sub-items a and k and Item No. 1-f. Likewise, non-teaching personnel shall be granted Compensatory Time-Off (CTO) for all services rendered during weekends as members of the Brigada Eskwela working committees and/or voluntary services in the BE activities. Eight (8) hours of accumulated services are equivalent to one-day CTO.

 - a. 2023 Brigada Eskwela Individual Work Plan noted by the School Head;
 - b. 2023 Brigada Eskwela Individual Accomplishment Report (Pictures with label based on Individual Work Plan);
 - c. Duly Signed DTR; and
 - d. Duly signed Special Order (see attached Enclosure No. 1).
