This year, the Dangerous Drugs Board will undertake the following activities during the celebration of the 2023 DAPC Week from November 12 – 18, 2023, with the theme: People First: Stop Stigma and Discrimination, Strengthen Prevention:

- 1. Reading of Pastoral Letter on the DAPC topic during masses/church services nationwide. The announcement will be made through a pastoral letter courtesy of the Catholic Bishops Conference of the Philippines (CBCP) on November 12, 2023.
- Launching of BKD TODA. The DDB, through the Provincial Government of Ilocos Norte will be launching the Barkada Kontra Droga – TODA at the Robinson's Mall in Ilocos Norte on November 12, 2023.
- 3. Simultaneous Pledge of Commitment to Remain Drug-Free. Stakeholders/Duty Bearers are highly encouraged to recite their commitment during flag raising ceremonies on November 13, 2023.
- Poster-Making Contest. Initially, the contest will be held at the local level. Seventeen entries from the local government units will be semi-finalists. Only five (5) entries will be chosen for the finals. Awarding of winners will be held on November 17, 2023.
- Seminar on Addressing the Threats of Cyber Crime Against Drug Use and Illicit Trafficking. Participants are 100 ADAC representatives from Metro Manila to be held in Taguig City on November 15, 2023.

- 6. Seminar on Drug-Free Workplace for Government Employees. Participants will come from selected government employees in the National Capital Region.
- Community Service. All LGUs are encouraged to come up with activities such as medical/wellness program, clean-up drive, gardening, sewer dredging, counseling session for PWUDs and their families, etc.
- Sports Clinic. Target participants are at least five (5) interested out-of-school youth (OSY) and PWUDs in all LGUs in Metro Manila to be facilitated by the local government of San Juan City.
- Promotion of DAPC Week Celebration. Stakeholders are highly encouraged to put up or display tarpaulins, banners, or streamers in strategic places within their offices. Templates can be downloaded from the website of the DDB, www.ddb.gov.ph.
- 10. Organize your own 2023 DAPC Week celebration. Agencies and organizations are encouraged to conduct their own activities.
