## OBSERVANCE OF REPUBLIC ACT NO. 7836, OTHERWISE KNOWN AS THE "PHILIPPINE TEACHERS PROFESSIONALIZATION ACT OF 1994"

To: Schools Division Superintendents Assistant Regional Director School Heads All Others Concerned

- 1. Attached is a Memorandum from **Mr. Romel B. Balisang, LPT, MPA,** Regional Director, Professional Regulation Commission Regional Office VI dated October 4, 2023, with the subject "Observance of Republic Act No. 7836, Otherwise known as the **Philippine Teachers Professionalization Act of 1994**."
- 2. Relative thereto, all Registered Professional Teachers from 2001 to 2023 in the Schools, Schools District Offices and SDOs who failed to claim their Certificate of Registrations (COR) shall **authorize the Personnel Officer** of the Schools Division Office to claim their COR at the Professional Regulation Commission (PRC), Regional Office VI.
- 3. Head of Schools / Public Schools District Supervisors shall submit the collated Authorization Letter (Annex A of PRC Memorandum) signed by teachers, to their respective Schools Division Offices for submission to DepEd Regional Office VI.
- 4. The registered professional teachers at the Schools Division Offices and Regional Office Proper who also failed to claim their COR shall be included in the submission of the authorization letter.

This has reference to our letter dated 11 August 2023 on the unclaimed Certificate or Registration (COR) of professional teachers in Region VI.

It has come to our attention that many of our professional teachers in the region who are practicing their profession do not have in their possession their COR and do not have a valid Professional Identification Card (PIC). Upon verification, there are currently more than 23,000 unclaimed CORs in the custody of PRC Regional Office VI.

Anent this, we invite your attention to the Republic Act (R.A.) No. 7836 otherwise known as the "Philippine Teachers Professionalization Act of 1994", the regulatory law governing the profession.

Sections 17 and 27 of the said law provide:

Section 17. Issuance of Certificate of Registration and Professional License – xxx Every registrant who has satisfactorily met all the requirements specified in this Act shall, upon payment of the registration fee, be issued a certificate of registration as a professional teacher bearing the full name of the registrant with serial number and date of issuance signed by the chairman of the Commission and the chairman, vice-chairman, and members of the Board, stamped with the official seal, as evidence that the person named therein is entitled to practice the profession with all the rights and privileges appurtenant thereto. The certificate shall remain in full force and effect until withdrawn, suspended and/or revoked in accordance with law.

A professional license signed by the chairman of the Commission and bearing the registration number and date of issuance thereof and the month of expiry or renewability shall likewise be issued to every registrant who has paid the annual registration fees for three (3) consecutive years. This license shall serve as evidence that the licensee can lawfully practice his profession until the expiration of its validity.

Section 27. Inhibition Against the Practice of the Teaching Profession. - Except as otherwise allowed under this Act, no person shall practice or offer to practice the teaching profession in the Philippines or be appointed as teacher to any position calling for a teaching position without having previously obtained a valid certificate of registration and a valid professional license from the Commission. (Emphasis supplied)

Pursuant to the above provisions, teachers are mandated by law to secure their COR and a valid PIC to lawfully practice their profession.

For faster and more efficient release of CORs, those who are employed by the Department of Education may claim their CORs through an authorized representative/liaison officer.

For convenience, attached as Annex "A" is the Letter of Authorization they may use should they wish to claim their COR from the PRC through their authorized representative/liaison officer.

In this regard, we are requesting full support from your good office in the faithful observance of R.A. No. 7836.
