

This has reference to the initiative of the Department of Education (DepEd) through the Learner Rights and Protection Office in partnership with the Stairway Foundation Inc. to cascade knowledge on the aspects of learner rights and protection with the roll-out of the Child Protection (CP) E-Learning Course for Educators.

The aforementioned course is specifically designed for educators to develop a deeper understanding of the various child protection concerns that their learners might face both offline and online. Specially crafted by the DepEd Learner Rights and Protection Office and Stairway Foundation, the course aims to empower educators to have the knowledge and tools to participate more in the protection of the children they work with.

The Learner Rights and Protection Office in partnership with Stairway Foundation Inc. offers the CP E-Learning Course for Education online course for the teachers in the DepEd free of charge. The course is NEAP accredited with corresponding professional development credits which amount to 15 CPD points. It will run from October 23 to December 23, 2023.

The course will be opened to ten thousand (10,000) participants across the nation with six hundred and twenty five (625) participants in each region.
