The Soil Transmitted Helminthiasis Prevention and Control Program (STH-PCP) of the Department of Health Western Visayas Center for Health Development (DOH WV CHD), in cooperation with the provincial and city health offices will be conducting the harmonized schedule on combined mass drug administration (HSCMDA) on January and July 2024 for community-based, and March and September 2024 for school-based. This activity is being implemented to reduce the prevalence of soil transmitted helminthiasis in vulnerable populations, especially school-aged children.


