In relation to the issued unnumbered Memorandum of the Office of the Secretary dated December 15, 2023¹ titled, "Guidance on the Releasing of Service Recognition Incentives (SRI)" and Memorandum no. OUF-2023-0754 dated December 18, 2023², titled "Reminders in Relation to the Release of FY 2023 Service Recognition Incentive (SRI)", this Office instructs all Regional Offices (ROs), Schools Division Offices (SDOs), and Implementing Units (IUs) of the following:

- All unclaimed said incentives of the eligible personnel should be credited directly to their respective payroll account, not later than January 26, 2024 (Friday) to:
 - Relieve the Special Disbursing Officers of their responsibility and accountability in safekeeping the cash advance for the payment of the SRI and GP for FY 2023; and
 - Ensure that all eligible personnel can receive the incentive.
- All field officers are also instructed to inform the recipients before crediting the said incentives to their respective payroll accounts.

Furthermore, all ROs shall accomplish and submit their consolidated report on the grant of the FY 2023 SRI using the provided editable template attached as "Annex A" and upload the PDF and Word files of the said report using the following link https://bit.ly/ReportonFY2023SRI not later than January 29, 2024 (Monday) for consolidation at the DepEd Central Office and submission to Department of Budget and Management (DBM) not later than January 31, 2024. This is in compliance to
