- 1. In consonance with DepEd Order No. 28, s. 2018 titled "Policy Guidelines on Oplan Kalusugan sa Department of Education" and Republic Act No. 7719, also known as the National Blood Services Act of 1994, this office through the School Health and Nutrition Unit of the School Governance & Operations Division (SGOD), in partnership with the Philippine Red Cross Capiz Chapter, will conduct a bloodletting activity with the theme "Dugo mo Sugpon sa Kabuhi ko Part 3" on February 19, 2024, from 8:00 AM to 5:00 PM at the Schools Division Office Activity Area, Banica, Roxas City.
- 2. This activity aims to:
  - a. encourage everyone to voluntarily donate blood, which will increase the blood bank reserves and eventually become very important in saving the lives of those in need;
  - b. inculcate public awareness that bloodletting activity will not only benefit the recipients but the donor as well.
- 3. In line with this, all interested and qualified teaching and non-teaching personnel of this division are requested to voluntarily donate blood during the conduct of the above activity.
- 4. It is understood that in the conduct of this activity, there shall be no discrimination on account of age, school, gender, civil status, disability or other factors, and personal circumstances contrary to the principles of equal opportunity.
- 5. Meals and snacks during the conduct of this activity shall be charged against the Division MOOE funds while traveling expenses of donors are chargeable against school MOOE subject to usual accounting and auditing rules and regulations.
- 6. It is expected that in the conduct of this activity, all involved must adhere to the existing minimum health and safety protocols.
