CAPACITY DEVELOPMENT ON SCHOOL SITES TITLING

- This Office, through the Sites Titling office (STO) under the Legal unit office shall conduct a CAPACITY DEVELOPMENT ON SCHOOL SITES TITLING on October 14-17 and October 28-31, 2025. The venue shall be announced later.
- 2. This activity aims to:
 - a. Legal Framework and Documentation Review Participants will be oriented on the pertinent laws and regulations governing the proper procedures for processing land titling documents. This includes identifying missing or incomplete documentation for each school site to ensure compliance and readiness for title registration.
 - b. Registration and Transfer Procedures The session will cover the detailed flow and process involved in the registration and transfer of Certificates of Title for school sites at the Registry of Deeds, highlighting key steps and common challenges.
 - c. Special Patents under RA 10023 An in-depth discussion will be held on the Guidelines for the Processing and Issuance of Special Patents for Public School Sites pursuant to Republic Act No. 10023. The presentation will outline the step-by-step procedures for filing a Special Patent and securing individual land titles for public school sites.
