**SECOND ROUND OF SCHOOL-BASED MASS DRUG ADMINISTRATION
FOR DEWORMING**

To: Assistant Schools Division Superintendent
Chief Education Supervisor (CES) / OIC - CES
Public Schools District Supervisors
Heads of Public Elementary, Secondary and Integrated Schools
District and Secondary School Health Coordinators
All Others Concerned

1. In accordance with the **Integrated Helminthiasis Control Program: School - Based Deworming**, the Department of Education and Department of Health will be conducting the **Second Round of School-Based Mass Drug Administration for Deworming**.
2. In this connection, this Office will conduct a simultaneous **School-Based Mass Drug Administration (MDA)** in all schools on **September 26, 2025**. All elementary, secondary, and integrated schools are hereby advised to submit one (1) hard copy of their Mass Drug Administration (MDA) report for school-aged children on or before **October 17, 2025**, to the School Health Section, School Governance and Operations Division (SGOD), attention: Joy Arnold T. Lejos, Medical Officer III.
3. Parents' permit signed by the parents or guardians must be gathered a day before deworming.
4. Teachers will be the ones to administer or give the oral deworming tablets to their respective pupils from Kinder to Grade 6 and Grade 7 to Grade 12. The personnel from School Health Section will assist and monitor the implementation of deworming activities.
5. It is understood that in the conduct of this activity there shall be no discrimination on the account of age, school, gender, civil status, disability, religion or similar factors and personal circumstances that run counter to the principles of equal opportunity.
6. Immediate dissemination of this Memorandum is desired.
