**PROGRAM IMPLEMENTATION REVIEW (PIR) ON RESEARCH
AND DATA MANAGEMENT**

To: Schools Division Superintendents

1. This Office, through the Policy, Planning, and Research Division, (PPRD), shall conduct the **Program Implementation Review (PIR) on Research and Data Management** within Capiz on December 15-17, 2025, inclusive of travel time.
2. The aims of this activity are the following:
 - a. present CY 2025 accomplishments of the SDOs,
 - b. share best practices on the implementation of research and data management,
 - c. identify technical assistance needs of the SDOs in terms of research, planning, and data management; and


